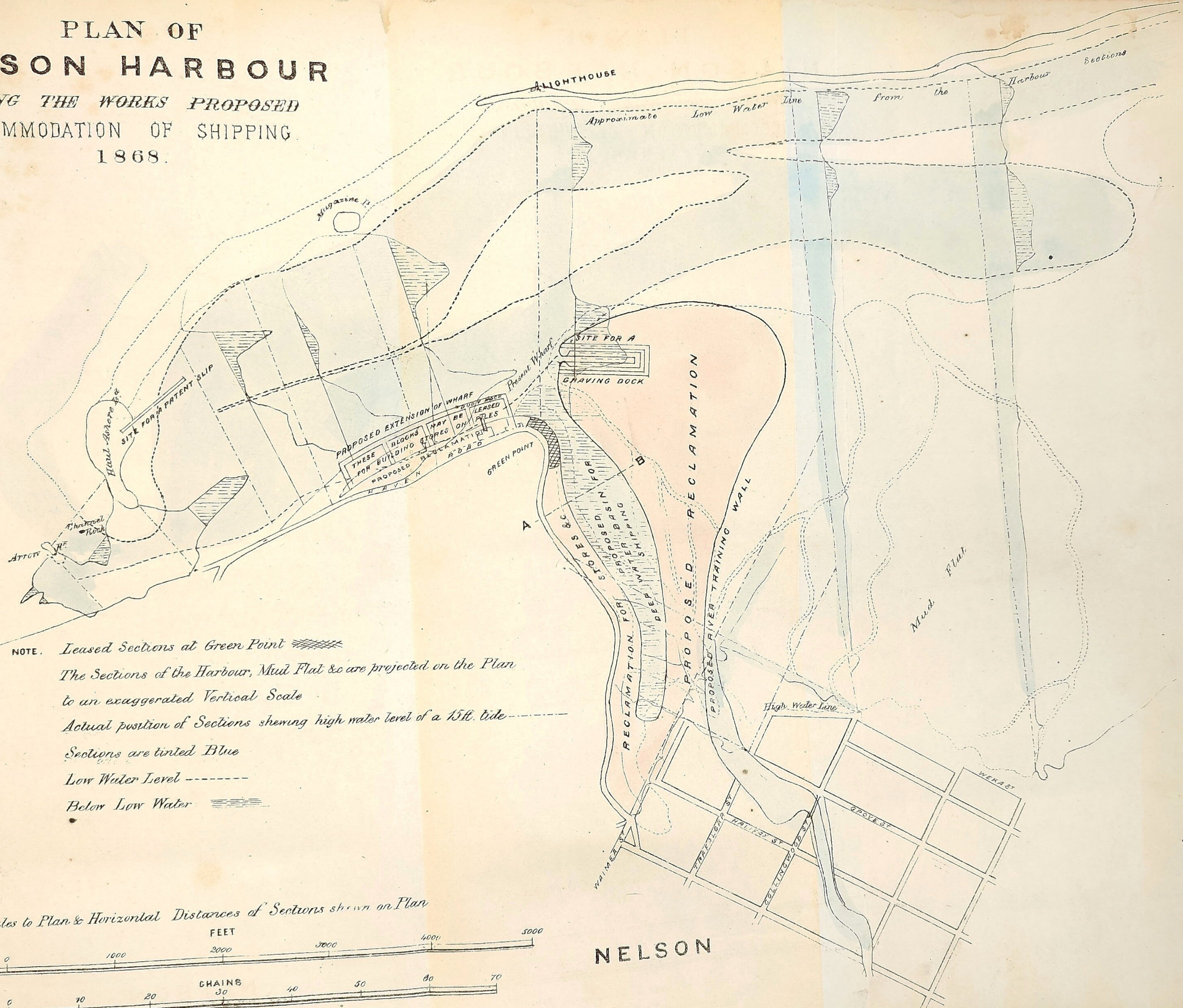

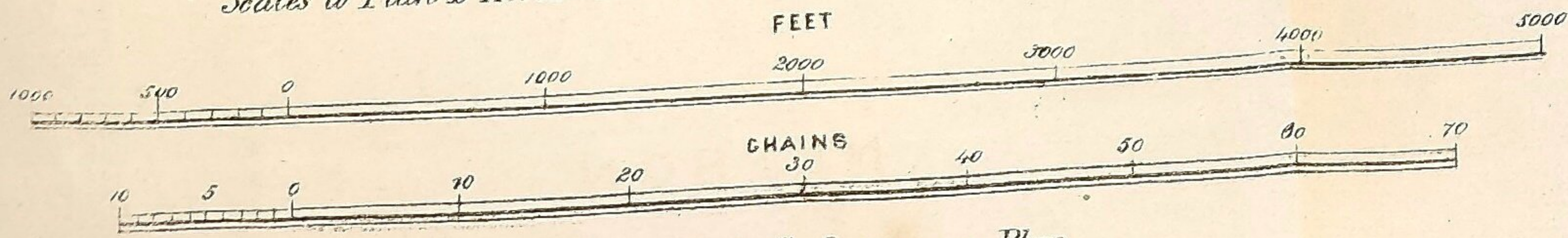
PLAN OF NELSON HARBOUR

1868.

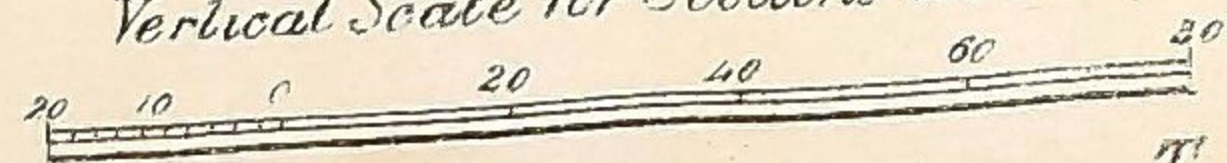


NOTE. Leased Sections at Green Point
